



### ***2011 “Angels of Hope” Charity Walk***

The “Angels of Hope” Charity Walk is the annual fundraiser to support the Noah-Christian Community Center and it’s Outreach Ministry. NCCC offers free educational services to the youth and families of the Roanoke Valley and abroad.

Businesses and organizations are welcome to sponsor the event by becoming a vendor and/or creating a team of individuals to walk for the cause. Registration fee is \$25 per walker; Vendor fee is \$100 per business/organization. All donations are tax deductible. Please see Federal ID number on Vendor Form. NCCC will also provide a receipt of donation.

❑ ***Vendor Guidelines and Requirements:***

- Vendor fee allots space for up to a 12x12 tent (provided by business) with 2 to 4 individuals working the area.
- It’s requested that no physical products or exchange of monies take place on that day for the purpose is for all funds to support the walk proceeds. This is a charitable event and one that will bring great exposure to all participating vendors. You may however set up products for display and/or sign-up individuals for consultations, new accounts, etc. If you’re representing an organization such as Mary Kay, Premier Jewelry, Pampered Chef, etc. you are encouraged to schedule individuals for parties as well as seek new independent consultants for the business. ***(All vendors are responsible for their area. NCCC, Inc will not be held responsible for any damages and/or items)***
- It’s suggested that vendors dress in business apparel as well as provide several types of promotional items at their station to educate and offer

awareness. Be as creative as you like. The more attention drawn to your station the more traffic you will receive!!

- Vendors are allowed to do drawings or give away items. The charity walk holds a Silent Auction and businesses are encouraged to donate a product, gift certificate, etc towards the event. You may also do a drawing and/or give away at your own set up station to draw individuals to your area. ***Please consult NCCC, Inc. prior to for approval.***
- Requested that representatives of businesses or organizations not force themselves on walkers or participants of the charity walk. This is a family event and one generated to create a day of fellowship, remembrance and fun. We desire that individuals visit each station on a volunteer basis. Based on past events, that will not be a problem.
- The Charity Walk is from 8am-2pm however vendors may select their time of set-up; it is requested that set-up be completed by 9am. All will be asked to begin shutting down around 1pm however if a vendor needs to shut down prior to that time, it's at their own discretion.
- NCCC will assign a mapped area for each vendor so it's requested that you confirm your participation as well as estimated time of arrival by ***Monday, May 16, 2011.*** You may do so by completing the attached vendor form and mailing it back along with the \$100 fee to address provided.
